March Artist of the Month Tom Bender

Tom is a displaying member of the New Braunfels Art League; a juried member of the Art Guild of the Kennebunks, and a member of the Wimberley Valley Art League. He has served as the President of WVAL and currently is First Vice President of NBAL.

Tom is a "Digital Photo Artist" and has produced digital mixed media art, combining assemblage sculpture with photography and experiments with digital painting. His training was due to a fortuitous collection of mentors. His first mentor, perhaps the most influential, taught him to see the details in the reflections and the shadows.

Perhaps more important, he taught Tom how to capture those details on film. That profound experience was to shape the next forty years of Tom's photographic journey and result in true love of photography. Another mentor taught Tom graphic arts photography. Still another taught him the fine points of lighting in portrait photography as well as darkroom technique, and manipulation on the enlarger easel and the developing tray.

Tom's move to Maine and back to Texas transitioned him from film to digital -- a natural path that reflected his history in the graphic arts. He has learned to use the tools that Photoshop offers the artist. He continues working with multiple images combined into a single piece of art with results that range from very traditional to surreal. Most of his photography output is pigment ink on gallery wrapped canvas.

His sense of humor is evident in his finished work. Some of his artwork raises questions, some pieces will pull your leg and some will tug at your heart.

What's Happening in the Gallery.

We had a kick-ass brainstorming meeting Tuesday. Carolyn Pittman was a great facilitator and we will publish the most popular suggestions at the next meeting and start talks about implementing them.

Some suggestions can be implemented right now and are actually in our rules and guidelines for **Docents on duty:**

Greet guests when they enter the gallery, Demonstrate in the front, Use the lunch area for lunch-not projects, Arrive on time and close on time.

If you think no one notices, if you are late, or don't greet guests, or work on your projects in the back, think again. Our members who do their fair share notice when others don't. There has been much discussion in the Team Boards and the Executive Boards about enforcing these rules. We do not want to become the docent police, but there is a general rumbling in these two boards that there ought to be consequences for the docents who do not do their share. This was a theme in the brainstorming meeting as well, and will be discussed and acted on in the very near future.

WE WILL NOT LONGER ACCEPT DONATIONS IN THE LUNCHROOM. Generally the donations we are receiving create work for us to remove them. If you want to take magazines to a class or exchange frames with a fellow artist, please do so. Do not leave donations in the lunch room.

HOW TO..... become a displaying member at NBAL or add another media to your display inventory.

You must be **18 or older** to apply.

All art **work must be original**, that is, cannot have been done in a setting which involved any instruction (such as lessons, workshops, or classes). It cannot violate any copyright such as photos from magazines or use any photo without permission from the photographer.

Three examples of each medium that you are applying for are required in order to qualify for jury (i.e. 3 sculptures, 3 oil paintings, 3 watercolors, etc.). You may apply for up to 3 mediums.

All work submitted must be gallery ready (suitably framed, wired, and prepared as they will be displayed in the gallery; remember no saw tooth hangers and no cardboard backings).

Pick-up Jury process Information Form and Jury Process Application (ask the docents at front desk for **Jury Process Application** marked **ARTIST APPLYING TO DISPLAY FOR THE FIRST TIME** or the **Jury Process Application** marked **Current Member**). This is where you will find rules, step- by -step procedures for the jury day, along with prices.

All works should be of Suitable Subject Matter for a family oriented art gallery/organization.

ARTISTS APPLYING TO DISPLAY FOR THE FIRST TIME: 1st Saturday of November, 9:00am – 11:00am
CURRENT NBAL MEMBERS APPLYING TO DISPLAY or add ADDITIONAL MEDIUM/MEDIA: 1st Sat. of November, 9:00am – 11:00am OR 4th Sat. of Apr., 9:00am – 11:00am

ARE YOU READY???

These questions pertain to all media, all categories (2D work as well as 3D work).

The Scoring Rubric for the jury process is as follows:

1pt Exhibits No Attempts 2pts Exhibits Inconsistent Attempts 3pts Exhibits Consistent Skill 4pts Exhibits Mastery

- 1. Originality/Uniqueness (1-4pts)** **Are you working from **your own photos** or some from a friend who has given you permission? Are you working from **your own set-ups and subject choices??** Have you **done the work on your own** with no help from a teacher or instructor, not in a class or workshop???*
- 2. Quality/Consistency of all Three (1-4pts)** **You should **really** look at the three works you are submitting and ask yourself, "Are all 3 pieces my **best work to date**, and do they look like they are at the **same level of talent???**"*
- 3. Composition/Design/Balance (1-4pts)** **Can you look at each piece to be entered and say that the overall configuration or **arrangement has good design and is balanced** (doesn't look heavy one side to the other side)?*
- 4. Line/Shape/Texture/Space (1-4pts)** **Do you have **a pleasing variety of lines, shapes, and textures throughout the piece?** Do you have a good balance of positive and negative space; are they a pleasing shape??*
- 5. Color/Values/Form (1-4pts)** **Have you chosen a **suitable color scheme?** Is there **good dark and light values??** If the piece is 3D (sculpture, jewelry, etc.) does it **use the depth to a good advantage**, if the piece is 2D but giving the illusion of depth (objects look like they are round); does it look believable???*

If you can answer YES to ALL the questions above, then YOU ARE READY!!!!

Score yourself for each 3 pieces you are entering. If you can give yourself a score of 15 – 20pts then that body of work would be accepted.
